ACTIVEADVICE GUIDELINES TO AAL SOLUTIONS

ACTIVEADVICE USER TESTS & HUMAN ADVISOR WORKSHOPS

We are currently testing the ActiveAdvice platform with representatives of all three target groups – AAL2C (Consumers), AAL2B (Businesses) and AAL2G (Governments). The platform is tested in realistic but controlled environments, addressing usability, functionalities and the overall impression of the solution. In parallel, we are testing the concept of human advisors with different profiles in all countries represented within the consortium.

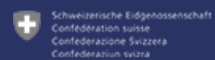
